A RESOLUTION TO MAKE TEMPORARY APPROPRIATIONS FOR 2012 EXPENSES FOR THE VILLAGE OF MCCONNELSVILLE

WHEREAS, it has come to the attention of the Council of the Village of McConnelville that it is necessary to make a temporary appropriation to adequately defray 2012 operating expenses; and

WHEREAS, it has come to the attention of the Council of the Village of McConnelville that unless a temporary appropriation is passed, the Village will not be able to meet its current obligations; and

WHEREAS, an emergency exists affecting the public health, safety and general welfare of the citizens of the Village of McConnelville.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MCCONNELSVILLE, COUNTY OF MORGAN, STATE OF OHIO as follows:

Section 1: That a temporary appropriation be made to defray 2012 operating expenses in the following funds in the following amounts:

That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and general welfare of the people of the Village of McConnelville, Ohio, and therefore this Resolution shall be in full force and in effect immediately after its passage.
